A Resolution to Enter into a Professional Services Proposal with RVi Planning and Landscape Architecture for Design Engineering Services for Route 66 Park

Village Manager, Dawn Caldwell, began by thanking the board and explained that there will be a Route 66 themed park along Route 53. It is the hope that it provides a memorable stop along the historic roadway. Chris Drey, Public Works Director, explained different options will be considered along with additions of parking and overall improvements. Mayor Noak commented that it is great timing as it's the anniversary of Route 66 and our history and integration with the roadway. Mrs. Caldwell then continued by explaining that since the proposed Route 66 park is on the current Veterans Memorial, the memorial will be moved to the Village Hall campus to encourage more visitation. Mr. Drey shared the new location of the Veterans Memorial. Mayor Noak commented that the site has served us well over the years, but it is time to expand to include the additional branch of the military. Trustee Richards commented that he likes the new site as it is quiet and

can be enjoyed year round instead of just on a holiday. Trustee Clancy shared that more people will be able to visit. Mayor Noak elaborated on the fact that it will still be the Doc McCartan memorial and we will reuse the current structures.
